

## Cookie statement

The Foundation uses cookies on this website. Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.

We use functional cookies to make our website work. In addition, we use analytics cookies to find out how people engage with our website. Functional cookies and analytics cookies that have no or limited consequences for data subjects' privacy rights fall under the exception of Article 11.7a(3) of the Dutch Telecommunications Act. Therefore we do not need to ask permission to place them.

If you consent to their use, we use tracking cookies. Tracking cookies are cookies that can track visitors as they browse other websites. These cookies allow us and our partners to track the effectiveness of our marketing campaign and to display personalized advertising.

### 1. Strictly necessary cookies

We use strictly necessary cookies on our website. A strictly necessary cookie is a cookie that is essential for the functioning of a website and does not require user consent. The processing of these cookies ensures that the website visitor is anonymous, and so the visitor is not identifiable from these cookies.

The table below lists all strictly necessary cookies that are placed during a visit to our website.

When the pixel loads, Facebook places a so-called "fr"-cookie on your computer, which helps Facebook to provide you with more personalized advertisements, but also to measure and improve advertisements.
